Copy/Extract of the Paragraph Agenda Item from the minutes of the meeting of the SENATE held on 24.9.2006.

The recommendations of the Syndicate contained in Items 83, 84, 85, 86, 87, 88, 89, 90, 91, 92, 93, 94 and 95 on the agenda were read out, viz. -

83. That the students of M.A. I (Economics), session 2005-2006, of Mata Ganga Khalsa College for Girls, Kottan (Ludhiana), be allowed to appear in the examination in the capacity of private candidates, with the following stipulation: ✓

- (1) the examination fee already paid by them be adjusted and balance, if any, be got deposited by the students;
- (2) conversion fee from regular to private appearance be not charged from these students; and
- (3) late fee be not charged from these students.

84. That Gobindgarh Public College, Alour, Khanna (District Ludhiana) be granted permanent extension of affiliation for B.A. English and Punjabi (Compulsory and Elective), Hindi, Economics, History, Political Science, Music (Vocal) and B.Com. classes from the session 2006-07 subject to purchase of books worth Rs.3000/- to Rs.5,000/- in each subject.
